

Terms and Conditions

Please read and ensure that you fully understand all the implications of these Terms and Conditions before signing and returning this contract

1. Terms used in this contract. **"The Customer"** will be the person signing this contract and undertaking to abide by all details, terms and conditions detailed herein. **"Party Sounds 4 U"** or **"We"** will be the company providing the services to, or on behalf of the Customer. **"The Parties"** refers to The Customer and Party Sounds 4 U. **"The Contract"** refers to this document.
2. Party Sounds 4 U will hereby agree to provide a DJ service for the customer as detailed under the **"Event Details"** section of the contract overleaf.
3. The Customer is responsible for all fees due to Party Sounds 4 U.
4. A non-refundable booking fee of 25% of the quoted fee must be paid, within 7 days, to secure a booking. The booking is not considered final until you receive our confirmation.
5. The final balance, whether paid by Cheque, Cash or Bank Transfer, must be made **at least 10 working days prior to the event** (to allow for clearance).
6. Performance times and the venue specified at the time of booking will be adhered to in accordance with the contract. However, on the night of the function, additional performance time may be negotiated. This is at the DJ's discretion and subject to additional fees, as specified overleaf, payable in cash, and prior to continuation.
7. Party Sounds 4 U are happy to accept music lists and requests in advance of functions. We will endeavour to play the customers chosen requests, provided such requests are submitted in writing, at least 3 weeks before the event. We will also endeavour to play individual tracks requested by the customer or their guests on the night, however, for legal copyright reasons, we will only play client provided tracks if they are supplied on original audio CDs.

Cancellations

9. Cancellations, by the customer, must be made in writing at least 30 days prior to the date of event. If this is not complied with, a fee of 50% of the total cost will be charged to the customer. Cancellations made within 7 days of the event will result in the full fee being charged.
10. In the extremely unlikely event of us having to cancel, Party Sounds 4 U will refund any monies already paid to us in full, and as a gesture of goodwill, will pay an additional 25% of the full event price detailed overleaf. This will be the full extent of our liability.
11. In the exceptionally unlikely event of us suffering catastrophic equipment failure, resulting in non-fulfilment of any of the services Party Sounds 4 U supply, we will refund any payment on a pro rata basis of the booked time remaining. No further compensation can be claimed.

Venue

12. We require access to the venue at least 60 minutes prior to the event and 60 minutes after the event to set up and pack away. If the performance start time is delayed due to the inability of the company to gain access to the performance area, or any other delay beyond the company's reasonable control, no liability will be accepted and no refund will be given.
13. We require provision for parking within 20 metres of the venue entrance.
14. It is the customer's responsibility to ensure that the venue has a working, and safe, double 13 amp socket (2 preferred) within a reasonable distance of where you require us to set up.
15. Party Sounds 4 U will not be liable for breaches of by-laws, or conditions under which the venue is leased, hired, or entrusted to the customer.

Health and Safety

16. Party Sounds 4 U will ensure that all electrical equipment used will be compliant with the relevant Health & Safety legislation regarding the equipment and personnel. Having been tested for electrical safety, a PAT (Portable Appliance Test) certificate will be available for inspection. The company is not responsible for any damage caused to the room or building where the services are provided and is not responsible for any power outages.
17. A laminated copy of our public liability insurance will also be available for inspection.
18. We reserve the right to cancel our services should we discover that the venue is unsuitable or dangerous, e.g. if the power provided is not capable of operating the equipment without risk of damage to the equipment, company or the public, or if the working environment constitutes a health and safety risk. If applicable, the customer agrees to furnish a facility that completely covers/protects Party Sounds 4 U equipment from direct sunlight or rain/water ingress. If service must be discontinued for any of the aforementioned reasons, no refunds will be awarded.

Conduct

19. It is the customer's responsibility to ensure the good conduct of their guests. If at any time, before or during the event, we deem our persons or property to be under threat, we reserve the right to terminate our services with immediate effect. In these circumstances no refund will be made, and we reserve the right to claim damages.
20. The customer will be responsible for the costs of any theft or damage, normal wear and tear excluded, to equipment (sound/lighting/music equipment) caused by anyone in attendance at the event during the contracted time period, including the time allowed for setting up and packing away, unless damage is due to Party Sounds 4 U's own negligence. The full cost of any repairs/replacements required will be charged to the customer who will be advised of any damage as soon as possible.
21. The customer will provide suitable adult supervision for children attending the disco. This may include assisting the DJ in the organising of children during games played at the event (if required).
22. The supervising adult(s) will ensure that the children do not interfere with the disco equipment or with the DJ performing his duties.
23. Party Sounds 4 U agree to conduct themselves in a sober and proper manner and respond to the reasonable wishes of the customer as to the volume and location of equipment or other matters concerning people's enjoyment of the event.

Miscellaneous

24. Party Sounds 4 U is not responsible for obtaining any licence that may be required to stage the event. The customer shall ensure that any such licences' are obtained prior to the event. If they are unable to obtain this and need to cancel the event, please refer to the conditions above. A Public Performance Licence is required if persons attending your event are being charged an entrance fee. Therefore a licence is not required for private parties such as Weddings and Birthday celebrations.
25. The company may take photographs before or during events, and these may be published for promotional reasons and/or published on its website, all copyright is held by Party Sounds 4 U, and we may use pictures showing peoples faces, if you do not agree to this, you must let the company know prior to your event.
